This letter also guarantees products produced, and distributed by **L & P PROVISIONS** is not adulterated or misbranded and is operating under Sanitation Operating Procedures,(SSOP), Good Manufacturing Procedures,(GMP) and complies with the United States Department of Agriculture,(USDA).

Our HACCP plan is continually monitored and updated, and complies with Notice 44-01 Dated 11-04-02 and includes a CCP and a clarification for addressing and reducing the growth rate of Pathogenic Bacteria. E.Coli 0157:H7 falls under the same category as Pathogenic Bacteria, which growth rate is reduced at a temperature of 40 degrees F. or below.

There is an ongoing verification of compliance to Notice 4-04 Dated 01-09-04 for all beef suppliers concerning Bovine Spongiform Encephalopathy (BSE), as well as removal of Specific Risk Materials (SRM).

In addition Advance Meat Recovery (ARM) meats have never been used.

Allonco Inc. is a USDA facility Establishment # 34661. Our HACCP plan has been approved by the USDA.

All operation taking place with in this facility follow the strict guidelines set forth in our HACCP plan.

Allonco Inc. use boneless beef briskets and rounds in their pickling and cooking process. These products are not considered to be SRMs (Specific Risk Materials considered to be a risk of BSE by the USDA).

Allonco Inc. complies with Federal Register #4-04 and #7-04 regarding BSE safeguards. We have letters from our suppliers which support this statement.

Allonco Inc. requires all of their suppliers to provide a letter showing they are HACCP complaint, and addressing the intervention of the presence of E-coi 0157:H7.

Allonco Inc. guarantees all products leaving their facility to wholesome shipped below 40 degrees, without odor or off condition appearance. We label all off our products with a Julian code.

- (b) Adulterated or misbranded within the meaning of any substantially similar state or municipal law or the subject, to the extent said law is then effective and applicable.

This guarantee shall not apply to misbranding arising out of the use of Buyer-applied labels.

PM Holdings, L.L.C.’s civil liability, if any, shall be determined by its General Terms of Sale applicable to sales of said products by PM Holdings, L.L.C. and by normal judicial processes.
